STATE OF ARKANSAS, AN ORDINANCE TO BE ENTITLED:**

**AN ORDINANCE TO ESTABLISH A SPECIAL WEAPONS AND TACTICS  
TEAM (SWAT) ALONG WITH A BUDGET #1000-422, AND TO AMEND  
THE ORIGINAL APPROPRIATION ORDINANCE #2017-39, THE  
ANNUAL OPERATING BUDGET FOR 2018 TO INCREASE THE  
PROJECTED REVENUE AND APPROPRIATE \$30,000.00 INTO THE  
SWAT BUDGET #1000-422-2002 EQUIPMENT.**

**WHEREAS:** There is a need to establish a Special Weapons And Tactics Team (SWAT) in  
Van Buren County; and

**WHEREAS:** A separate budget to purchase equipment #1000-422; and

**WHEREAS:** \$30,000.00 shall be appropriated into the SWAT budget #1000-422-2002  
Equipment.
