**AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2016-52, THE ANNUAL OPERATING BUDGET FOR 2017, TO APPROPRIATE \$6,000.00 IN THE CIRCUIT CLERK'S COMMISSIONERS FEE FUND #3039-102 AND \$9,000.00 INTO THE CHILD SUPPORT FUND #3012-102.**

**WHEREAS:** Monies have already been projected by the Treasurer; and

**WHEREAS:** This money needs to be appropriated into the appropriate budgets as stated above.

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT: \$6,000.00 be appropriated into the Circuit Clerk's Commissioners Fee Funds #3039-102-2002 (small equipment) and \$9,000.00 into the Child Support Fund #3012-102-2002 (small equipment).**

**AN ORDINANCE TO CREATE A NEW FUND #3504-400 FOR SPECIAL REVENUE GRANT FUNDS FROM THE EDWARD BYRNE MEMORIAL JUSTICE ASSISTANCE GRANT (JAG) PROGRAM AND TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2016-52, THE ANNUAL OPERATING BUDGET FOR 2017, TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$3,495.87, INTO THE JAG BLOCK GRANT FUND #3504-400.**

**WHEREAS:** The Department of Finance and Administration Office of Intergovernmental Services has approved Van Buren County to receive a Special Purpose Mini Grant from the Edward Byrne Memorial Justice Assistance Grant (JAG) Program in the amount of \$3,495.87 requiring no match. Identifying number CFDA #1.738; and

**WHEREAS:** The County has received a check for said amount, receipt #255, and must be expended and a final report completed by June 1, 2017; and

**WHEREAS:** It is a necessity this fund be created and these funds be appropriated in order to purchase the equipment listed on the attached quote.

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:**

**SECTION 1:** That Fund #3504-400 be created; and

**SECTION 2:** That the annual operating budget #2016-52 is hereby amended and \$3,495.87 is appropriated into the JAG Block Grant Fund #3504-400.

**AN APPROPRIATION ORDINANCE TO AMEND THE ORIGINAL APPROPRIATION ORDINANCE #2016-52, THE ANNUAL OPERATING BUDGET FOR 2017, TO INCREASE THE PROJECTED REVENUE AND APPROPRIATE \$2,000.00 INTO THE SHERIFF'S DEPARTMENT BUDGET #1000-400.**

**WHEREAS:** The Van Buren County Sheriff's Department has a Deputy who is designated, by contract, with the Southside/Bee Branch School District to be a School Resource Officer; and

**WHEREAS:** The County is refunded the salary for this Deputy by the Southside/Bee Branch School District; and

**WHEREAS:** The Southside/Bee Branch School District is to give this employee a bonus to be paid by the School District thru the County Sheriff's Department.

**NOW THEREFORE BE IT ORDAINED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT:** This money be appropriated into the Sheriff's Department Budget #1000-400 as follows:
