BE IT RESOLVED BY THE QUORUM COURT OF THE COUNTY OF VAN BUREN, STATE OF ARKANSAS, A RESOLUTION TO BE ENTITLED:

A RESOLUTION AUTHORIZING THE COUNTY JUDGE OF VAN BUREN COUNTY TO ADOPT A GRANT AGREEMENT ON BEHALF OF THE VAN BUREN COUNTY 911 OFFICE FOR A 911 SYSTEM UPGRADE.

WHEREAS: The Van Buren County Quorum Court has determined that 911 meets the eligibility requirements necessary to apply for a grant under the United States Department of Agriculture Rural Housing Service for a Community Facilities Grant (7 C.F.R. part3570, subpart B); and

WHEREAS: 911 has presented plans to purchase equipment to Upgrade the 911 System; and

WHEREAS: The Quorum Court of Van Buren County recognizes the need for the project, concurs its importance, and supports the 911 Department in its efforts to proceed with the same.

THEREFORE, BE IT RESOLVED BY THE QUORUM COURT OF VAN BUREN COUNTY, ARKANSAS THAT: The County Judge is hereby authorized to adopt a Grant Agreement between Van Buren County (Grantee) and the United States of America acting through the Rural Housing Service (RHS), Department of Agriculture, (Grantor) for purpose of securing Federal grant funds in the amount of \$41,000.00, 34.47% of the Project cost, to aid and assist 911 in executing the proposed project described herein and that the County Judge and Treasurer of Van Buren County is further authorized to administer the grant funds for this project.
